PESACH 5784 • MECHIRAS CHAMETZ • SALE OF CHAMETZ

Dear LJCAGBI Family,

During the Passover holiday, it is forbidden to own Chametz (leaven). Therefore, if one cannot dispose of all one's Chametz before Passover, the Chametz must be sold to a non-Jew.

Rabbi Meyers will be available at the Shul, to arrange for the sale of Chametz, on Sunday, April 14th following Shacharis from 9am-10am as well as Monday, April 15<sup>th</sup> – Thursday, April 18<sup>th</sup>, 15 minutes before the 7:15pm evening services. Please send an email at least 24 hours prior to [rabbi@ljcagbi.org](mailto:rabbi@ljcagbi.org) to confirm appointment and rabbi's availability.

Ideally one should do the authorization in person with the Rabbi (form may be filled out beforehand). As an alternative, if one cannot make to the synagogue, congregants may complete the following authorization form for the sale of Chametz and drop it off at the Shul office or send it in via fax, mail, or email. **Please note: All written authorizations must be RECEIVED at the Synagogue Office no later than Thursday, April 19<sup>th</sup>, 2024.**

**All Chametz will be purchased back one hour after Passover is over (Tuesday evening, April 30<sup>th</sup> @ 9:40pm).**
